Tuition Payment Plan

Tuition payments are due on or before the dates indicated below, according to the plan selected.

If no plan is selected, the ten-month payment plan will be chosen.

Tuition payments may be reduced by financial aid, scholarships and discounts.

- Ten-Payment Tuition Plan - \$120 payment plan fee per family billed July 1**
One Student: \$920 paid by July 10, 2018 on a monthly basis and concluding April 10, 2019
Two Students: \$1,740 paid by July 10, 2018 on a monthly basis and concluding April 10, 2019
- Four-Payment Tuition Plan - \$50 payment plan fee per family billed July 1**
One Student: \$2,300 paid by July 10, 2018, October 10, 2018, January 10, 2019, and April 10, 2019
Two Students: \$4,350 paid by July 10, 2018, October 10, 2018, January 10, 2019, and April 10, 2019
- Two-Payment Tuition Plan - \$25 payment plan fee per family billed July 1**
One Student: \$4,600 paid by July 10, 2018 and January 10, 2019
Two Students: \$8,700 paid by July 10, 2018 and January 10, 2019
- One-Payment Tuition Plan**
One Student: \$9,200 paid by July 10, 2018
Two Students: \$17,400 paid by July 10, 2018

SCHOOL POLICY REGARDING TUITION AND FEES

1. This is a binding contract for the payment of tuition. Tuition for one student is \$9,200; two students is \$17,400; and three students is \$25,600, **less financial aid, scholarships and discounts.**
2. The payment plan fee will be billed and payable in July, depending upon chosen payment plan.
3. Tuition and fees not received by the due date will result in a \$20 late fee.
4. There will be a \$200 charge per family if concession obligation is not met.
5. This tuition contract must be on file in the Business Office and tuition must be current in order for a student to begin classes each semester.
6. Academic reports and transcripts will not be furnished if tuition or any other financial obligations are not current.
7. If there is more than one contract on file for a student(s), ALL financial obligations for that student(s) must be met to be considered current.
8. If a student withdraws, tuition must be current through the month of withdrawal in order for transcripts to be released.
9. Seniors may not be allowed to participate in graduation exercises unless all tuition and fees are paid.
